4. Consideration and Action on the Following Consent Agenda Items:

- a. Approval of the Minutes of the Regular Board Meeting of December 18, 2018.
- b. Approval to authorize payments over \$25,000.00:
 - 1. LT. Resources, Inc, the amount of \$28,403.55, for Railroad Crossings on Old SH 48;
 - 2. Rudd and Wisdom, the amount of \$32,337.50, for Valuation report and actuarial services performed during the period July 1, 2018 through November 20, 2018;
 - 3. Tyler Technologies, Inc, the amount of \$36,896.00, for 2019 Annual subscription and user fees;
 - 4. SAAB Technologies, Ltd., the amount of \$96,000.23, for Klein System Annual Software Support/Maintenance for the period of January 13, 2019 to January 12, 2020; and

Commissioner Wood moved to approve all consent agenda items, Commissioner Cowen seconded, and the motion passed unanimously.

5. Consideration and Action on Assignments, Negotiations, Easements, Subleases, and Contracts in General.

Mr. Tyndal addressed the Board regarding the following items:

1. Venmar Shrimp, Inc./Labor and Prosper, Inc (Authority to negotiate)

Venmar Shrimp Inc. is selling their improvements under BND Contract 3975 to Labor and Prosper, Inc. and have requested to be released of their lease subject to the Board approving a new lease with Labor and Prosper, Inc. for the purpose of operating a shrimp boat dock. Commissioner Lopez moved to authorize the Staff to negotiate with Labor and Proposer, Inc. for a new lease and authority to negotiate a Release of Lease to Venmar Shrimp, Inc., Commissioner Cowen seconded, and the motion passed unanimously.

6. Consideration and Action to authorize the Port Director and C.E.O. and BND's Director of Engineering Services to execute License from the U.S. Army Corps of Engineers on the Bulk Cargo Dock Improvements project on behalf of the Port.

Mr. Campirano addressed the Board requesting authorization for the Port Director and C.E.O and BND's Director of Engineering Services to execute a License from the U.S. Army Corps of Engineers on the Bulk Cargo Dock Improvements project on behalf of the District. On July 11, 2018, BND Commissioners ratified a Memorandum of Agreement between the Brownsville Navigation District (BND) and the U.S. Army Corps of Engineers (USACE) on payment of contribution for USACE to perform a Section 408 review of the proposed Bulk Cargo Dock Improvements project. On December 20, 2018, BND Staff received an email from USACE Galveston District (SWG) Real Estate division with the License to perform the proposed improvements. The License stipulates the conditions and requirements by USACE for the installation of the proposed improvements and includes requirements on engineering and related documents for close-out of the project. The License requires signatures by the Port Director and C.E.O. as well as by the BND Director of Engineering Services. Commissioner Cowen moved to authorize Port Director and C.E.O., Mr. Eduardo A. Campirano, and BND Director of Engineering Services, Mr. Ariel Chavez II, P.E./R.P.L.S., to sign and execute the U.S. Army Corps of Engineers License to perform the proposed improvements to the BND's Bulk Cargo Dock, Commissioner Wood seconded, and the motion passed unanimously.
