CHANGES TO BID DOCUMENTS:

1. REVISIONS TO CONSTRUCTION DRAWINGS

- a. The **Construction Drawings** have been revised to add approximately 15 square yards (SY) to Item #1, **2" H.M.A.C. (Hot Mix Asphaltic Concrete) Pavement** of the **Mailbox Relocation Area** portion of the Bid table. This additional asphalt is to be installed at the East end of the driveway for the relocated mailboxes.
- b. Contractor shall saw-cut the existing asphalt on Harbormaster Road and shall place the additional asphalt in a triangular area at that location.
- c. Saw-cutting, removing the old asphalt, prime and tack coats, and any other work necessary to prepare the base and install this additional asphalt shall be subsidiary to other related pay items, and shall not be paid for separately.

2. REVISIONS TO BID FORM

- a. The quantity for Item #1, **2" H.M.A.C. (Hot Mix Asphaltic Concrete) Pavement** of the **Mailbox Relocation Area** portion has been changed from the original 115 SY to 130 SY to provide for the additional asphalt in 1. above.
- b. The units for Item #2, **8" Steel-Reinforced Concrete Pad for Mailboxes** of the **Mailbox Relocation Area** portion has been corrected from CY (cubic yards) to SY (square yards). The quantity remains at 15, which is correct.
- c. A revised **Bid Form** is included with this Addendum. Bidders must use this new **Bid Form** to submit their bid.

3. BID PACKAGE

- a. As discussed in the Pre-Bid Meeting, to be deemed responsive, a bid must include all the forms listed in the Table of Contents under **Bidding Documents**, fully filled out and signed where necessary.

The BIDDER, in compliance with your invitation for bids for the "**OSTOS ROAD TRUCK STAGING ENTRANCE DRIVEWAY**" project, having examined the drawings and specifications with related documents and the site of the proposed work, and being familiar with all of the conditions surrounding the construction of the proposed project, including the availability of materials and labor, hereby proposes to furnish all labor, materials and supplies, and to construct the project in accordance with the contract documents, within the time set forth herein, and at the attached unit prices. These price(s) are to cover all expenses incurred in performing the work required under the contract documents, of which this proposal is a part. These price(s) are firm and shall not be subject to adjustment provided this Proposal is accepted within ninety (90) days after the time set for receipt of proposals.

BIDDER hereby agrees to commence work under this contract on or before a date to be specified in a written "Notice to Proceed" to be issued by the OWNER and to fully complete the project within 45 (forty-five) calendar days, as defined in the specifications. BIDDER further agrees to pay as liquidated damages, the sum of five hundred (\$500.00) dollars for each consecutive calendar day thereafter as hereinafter provided in Article 3 of the Agreement.

BIDDER agrees to perform all work for which he contracts as described in the specifications and as shown on the plans, for the attached unit prices:

Upon receipt of written notice of the acceptance of this Bid, BIDDER will execute the formal contract attached within ten (10) days and deliver the Performance and Payment Bonds and Insurance Certificates as required under the GENERAL CONDITIONS. The Bid security attached in the sum of _____ (\$ _____) is to become the property of the OWNER in the event the contract, bonds, and insurance certificates are not executed or delivered within the time above set forth, as mutually agreed to liquidated damages and not as a penalty for the delay and additional administrative expense to the OWNER caused thereby; otherwise the Bid security will be returned upon the signing of the contract and delivering the approved bonds and insurance certificates.
